

## INDIANA MIDDAY ROTARY CHARITABLE GIVING OVERVIEW

Indiana Midday Rotary's mission is to provide service to others, promote high ethical standards and advance world understanding, goodwill and peace through its fellowship of business, professional, and community leaders. We are a charter of Rotary International, which recognizes the importance of high ethical standards in all of its activities by applying The Four-Way Test: Is it the TRUTH? Is it FAIR to all concerned? Will it build GOODWILL and BETTER FRIENDSHIPS? Will it be BENEFICIAL to all concerned.

Rotary International maintains a commitment to "Service Above Self", channeled through the following Five Avenues of Service that form the foundation of all club activity:

- 1. Club Service: Club Service focuses on strengthening fellowship and ensuring the smooth functioning of Rotary clubs.
- 2. Vocational Service: Vocational Service involves club members serving others through their professions and aspiring to high ethical standards. Rotarians, as business leaders, share skills and expertise through their vocations, and they inspire others in the process.
- 3. Community Service: Community Service is the opportunity Rotary clubs have to implement club projects and activities that improve life in the local community.
- 4. International Service: International Service encompasses efforts to expand Rotary's humanitarian reach around the world and to promote world understanding and peace. It includes everything from contributing to PolioPlus, a plan to eradicate polio throughout the world, to helping Rotary Youth Exchange students adjust to their host countries.
- 5. New Generations Service: New Generations Service recognizes the positive change implemented by youth and young adults through leadership development activities. These activities include Rotary Youth Leadership Awards, Rotaract Club and Interact Club service projects, and creating international understanding through the Rotary International Youth Exchange Program.

Since August 23, 1990, Indiana Midday Rotary Club has supported the efforts of charitable and not-for-profit organizations in Indiana, Pennsylvania. Indiana Midday Rotary funds projects that implement innovative ways of enhancing community and international volunteer service. Award amounts are based on the merit of the project. The average has been \$300, however awards of up to \$1000 have been granted. Funded projects benefit the local and world community and reflect the mission of Indiana Midday Rotary. Projects also contribute within at least one of the avenues of Rotary Service. Organizations MUST complete an Indiana Midday Rotary Grant Application to be considered for funding. Please note: Indiana Midday Rotary will not fund personnel or general operating expenses. In some cases, specialized, sub-contracted services are funded. Organizations must demonstrate their not-for-profit or non-profit status to be eligible for funding. Indiana Midday Rotary grant applications are due September 15, 2022.



Applications are reviewed by the Charitable Giving Committee (CGC) which ensures applications are complete, timely, and meet Indiana Midday Rotary's charitable giving guidelines described herein. CGC submits appropriate applications to the Indiana Midday Rotary Board of Directors for final approval. The application process is approximately 1 month long.
